#### 3924 Review of Actions

**Traffic Issues, Yatesbury** - Wiltshire Councillor O'Neill reported that the speeding issue, raised by Cllr Purslow for the CATG meeting had been missed off the Agenda in error. It was agreed to put the item on the Agenda for the October meeting to re-raise two items to go to the next CATG item for discussion.

Wiltshire Councillor O'Neill reported that the new A4 road surface was noisy at the moment but would improve once the surface beds down.

Cllr Tomlinson reported that the patching of the road at Park Lane had not been done when the A4 works were completed.

**Parish Steward** - Cllr Purslow had been in contact with the Parish Steward and agreed to contact him directly when any works needed to be undertaken.

**CIL Funding** - Cllr Tomlinson will be able to produce a cost plan for potential CIL funding for the Village Hall in time for the October meeting.

**War Memorial Site** - Cllr Grafton had investigated the costs of a small memorial site, and will report back at the October meeting.
